

## Animal Incidents:

### What are the rules about dogs barking?

City Code Section 9.1.150. Dogs Which Disturb Neighborhood. No person shall own, keep, or harbor any dog which by loud, continued, or frequent barking, howling, yelping, or by noxious or offensive odors shall annoy, disturb, or endanger the health or welfare of any person or neighborhood.

### What can I do about my neighbor's dog running loose all the time?

City Code Section 9.01.05. Dogs running at large. 1) It shall be unlawful for the owner or keeper of any dog to permit such dog to run at large. 2) It shall be unlawful for the owner of a dog to permit such dog to go upon the private property of any person without the permission of the owner or person entitled possession of such private property whether the dog is on or off a leash.

### What about dogs attacking my dog or cat?

City Code Section 9.10.10: Attacking dogs. It is unlawful for the owner or person having charge, care, custody, or control of any dog to allow such dog to attack, chase, or worry any person, any domesticated animal having commercial value, or any species of hoofed protected wildlife, or to attack domestic fowl. "Worry," as used in this section, means to harass by tearing, biting, or shaking with the teeth."



# ANIMAL GUIDE

**Frequently Asked Questions,  
Licensing, and Codes**

# Amount of Animals

## Dogs and Cats:

City Code 9.1.180. Number of Animals. It shall be unlawful for any person to have charge, care, or custody of more than 3 dogs. It shall be unlawful for any person to have charge, care, or custody of more than 4 cats.

## Bees:

City Code 19.05.08. Beekeeping.

Beekeeping is permitted use in any residential or agricultural zone so long as the requirements of this section are met, which are intended to reduce the problems that may otherwise be associated with beekeeping in populated areas. Covenants, conditions, and restrictions (CC&R's), bylaws, or other protective covenants of any subdivision shall not be enforced by the City.

## 2. General Requirements.

a. A beehive may be maintained in a side or rear yard of a residential lot as provided below:

i. No more than two beehives

per 5,000 square feet is allowed.

ii. Beehives shall have a

maximum height of 5 feet.

b. Any number of beehives is permitted in the RR, RA-5, and A Zones.

## Licensing:

City Code Section 9.02.01. It is unlawful for any person to keep, or harbor or maintain any dog four (4) months or more old unless such dog has been registered and licensed in the manner herein provided. The owner or custodian of any dog shall obtain a license for the animal within thirty (30) days after the dog reaches four (4) months, or, in the case of a dog over four (4) months, within ten (10) days of the acquisition of the dog. Person seeking dog license shall be eighteen (18) years of age or older.

## Chickens:

City Code Section 19.05.06. Keeping Chickens in the R1-40, R1-20, and R1-10 Zones.

a. Hen chickens (but not roosters) may be kept on a non-nuisance basis for the sole purpose of producing eggs, with no sale or income resulting from the keeping of chickens. For purposes of this Subsection only, chickens adversely affecting the physical health, which physical health condition must be documented, of an individual of an adjacent lot owner shall be considered a nuisance.

b. Up to ten hen chickens may be kept on any one lot or parcel.

In order to register your dog, you will need documentation that your dog's rabies vaccination is current and if your dog is spayed or neutered. ## Cost for Licensing

The cost for licensing is between \$15 to \$95. The cost depends on how many years you get the license (up to 3 years) and if the dog is spayed or neutered.
