


SURVEYOR'S CERTIFICATE

THE PURPOSE OF THE REQUESTED LOT LINE ADJUSTMENT BETWEEN LOTS 5615 & 5614 THE VILLAGE OF FOX HOLLOW NEIGHBORHOOD 5 - PHASE 6 IS TO PROVIDE LOT 5615 WITH A LARGER BACK YARD AND LOT 5614 WITH A LARGER FRONT YARD.


